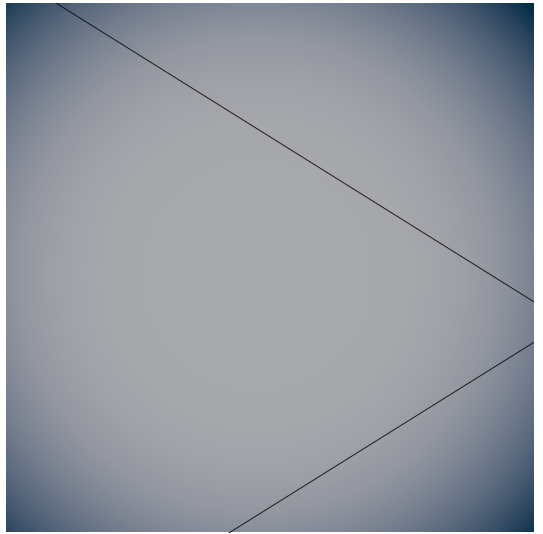


About Racine

Litigation, which is practiced within each department of the firm, has been part of Racine's DNA since its very creation and represents 50% of our activities.

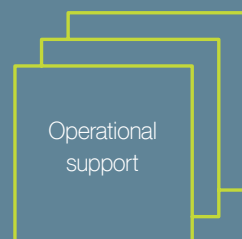
